The Pokagon Band is dedicated to providing community development initiatives such as housing, education, family services, medical care and cultural preservation for its approximately 5,700 citizens. The Pokagon Band's ten-county service area includes four counties in Southwestern Michigan

and six in Northern Indiana. Its main administrative offices are located in Dowagiac, Mich., with a satellite office in South Bend, Ind. In 2007, it opened Four Winds Casino Resort in New Buffalo, Mich., followed by Four Winds Hartford in 2011, Four Winds Dowagiac in 2013 and Four Winds South Bend in January 2018. It owns and operates a variety of businesses via Mno-Bmadsen, the tribe's non-gaming investment enterprise.
